NO.SO(ME)Admission-BSN/2023: In-continuation of this department's notification of even number dated 5th September, 2022 and in pursuance of decision of the Competent Authority i.e Provincial Cabinet in Agenda No.27, held on 06th February, 2023 for fixing criteria for admission in B.S Nursing (Generic) degree program for Academic Session 2022-23 in private sector institutions / colleges of Sindh Province following amendments are hereby made:-

Domicile: Candidate must be holding domicile of Sindh province.	All the applicants having domicile of Sindh will be accommodated and remaining vacant seats for admission shall be filled on open merit (other province) as per the criteria of admission only for Current Academic Session 2022-23.

"The Cabinet allowed the Health Department to amend the admission criteria for BS Nursing (Generic) only for academic session 2022-23 in the Private Nursing Institution / Colleges in Sindh Province with a condition that all applicants from Sindh must be accommodated before allowing applicants from other provinces to apply for the admission on remaining vacancies on open merit".
